

Authors and Publisher Responsibilities

'Euresian Publications' is dedicated to protect author's rights and ensures that all legal information and copyright regulations are addressed as per open access policy. We always try to maintain high standards of ethics while publishing articles in our journals.

- 1. Publication of an article in a peer-reviewed journal is an essential task in development of ideal, useful and creating a standard network of knowledge therefore we believe that author, editor and reviewers should behave with the truth of clarity over research matters.
- 2. 'Euresian Publications' acts as guardian of the scholarly articles published in the varied issues.
- 3. We are working closely with other publishers, industry associations, government organisations and non governmental organisation to set standards for best practices and to publish scientific and ethical matters without errors.

Authors' Responsibilities

Authors will also need to know about their responsibilities while publishing an article.

- 1. Authors should try to avoid the conflicts arising from financial support, involvement of other non-author parties in research study. They should provide information if any problematic situation exist while publishing an article. Other examples of conflict may include past/present employment, laboratory expenses, patents, paid experts etc.
- 2. If funding has been provided for the research study, all sources of funding must be declared.
- 3. Authors must describe the role of research study sponsor(s), if any in study design, in collection, analysis and interpretation of data, in writing of the report and decision to submit the paper for publication.
- 4. In order to comply with data protection and privacy rules, each individual who appears in any photograph or image, must be made aware about such inclusion.
- 5. If it is observed that articles are breaking professional ethics, are submitted to another journals and contains fraud in case of authorship with plagiarized content; in such cases they are directly removed from the online website and authors will be black listed and will not be allowed to publish in future publications.
- 6. Authors should present an accurate account of the work performed as well as an objective and discussion of its significance.
- 7. A paper should contain sufficient details about all the points, sub points along with references to permit others to replicate the work.
- 8. Wrong interpretation, fraud matters and inaccurate statements constitute unethical behavior and are unacceptable in the journals of 'Euresian Publications'.
- 9. Authors may be asked to provide the raw data in connection with a paper for editorial review and should be prepared to provide public access to such data.
- 10. The authors should ensure that they have presented original and novel work and also taken care to quote the appropriate citations.
- 11. Plagiarism in all its forms constitutes unethical publishing behavior and is unacceptable. You can read a separate attachment related with the plagiarism, available on our website.
- 12. Author should not replicate the general research data and should try to avoid the similarities with previously published articles to keep novelty and originality.
- 13. Submitting the same manuscript at a time to more than one journal is unacceptable and is purely an unethical behavior.



- 14. It is necessary to give proper acknowledgment of the work of others. Authors should cite publications and references in detail as per author guidelines.
- 15. Authorship should goes to them who have made a significant contribution in concept design, implementation or interpretation of the study. All others who have made significant contributions should be listed as co-authors.
- 16. The corresponding author should ensure that all appropriate co-authors included with sufficient credit and involvement in the work and all of them have seen and gave green signal in submitting the manuscript for publication.
- 17. If the work involves harmful chemical, procedures and such equipment which may cause injuries or damage to the health of all; such works should be clearly explained in the article.
- 18. Ethical use of animals and human tests should be supported with appropriate certification granted by the respective government authority.

Duties of Reviewers

Responsibilities:

We need our editors and reviewers to be key figures in their professions to have some experience of publishing articles and papers. A reviewer's comment decides the acceptance or rejection of an article so they play an important role in peer review process. All the members are requested to test out the manuscripts submitted to them without any bias to increase the quality of our journal. There is no hard and fast rule to analyse a manuscript and it depends upon the worthiness, quality and originality. Peer review is an essential component of formal scholarly communication, and lies at the heart of the scientific method. While verifying the manuscript you have to go through following points.

- 1. Detailed examination and relevance of the manuscript as per author guidelines.
- 2. Careful examination of purpose and objectives of the work carried out.
- 3. Correctness of the conclusions and recommendations along with up-to-date references.
- 4. Copyediting and proofreading of the manuscripts in accordance with publishing standards especially with grammar, punctuation and spelling.
- 5. Coverage areas of the manuscript in relevance with the scope of journal.
- 6. Plagiarism related issues if any.
- 7. You have to give at least six suggestions and based on the structure of the manuscript.
- 8. You have complete authority to accept or reject manuscripts but final decision in case of sensitive titles about the inclusion or exclusion from the publications remains in the hands of Editor-In-Chief.

Editor

- 1. Editor should evaluate the manuscripts initially without regard to race, gender, sexual orientation, religious belief, citizenship etc.
- 2. The editor and any editorial staff must not disclose any information about a submitted manuscript to anyone, other than the corresponding author.
- 3. Submitted information and ideas must be kept confidential and cannot be used for personal advantage or gain.
- 4. Editors should pass the final acceptance only after discussion with the other managing and coeditors and reviewers based on the compliance, originality and quality of the article.
- 5. It is the duty of editors to correct the articles if demand comes from authors. If needed, other appropriate action should be taken at the time of processing of the article.
- 6. Editor should address and take sufficient steps about ethical complaints to the published data and/or methodologies. Further communications should be made to the corresponding authors.

Article Posting Policies

We routinely modify our policies based on the demand and to respond the needs of the scientific communities. They are mainly related with addition, deletion, rearrangement of author names in the authorship or uploading newer form of the article based on the editorial/reviewers comments. If there is any request to add, change, rearrange the name of the authors before publication of the article, it must be sent to the editor of the journal by corresponding author with reason behind such changes and a written confirmation of agreement from all other authors (hard copy or scanned image).
